INCREASE IN THE MAXIMUM ALTERNATIVE VETERAN'S EXEMPTION

Section 1. The purpose of this law is to increase the maximum exemption allowable in Real Property Tax Law, Section 458-a(2) a, b, and c to eighteen thousand dollars (\$18,000), twelve thousand dollars (\$12,000), and sixty thousand dollars (\$60,000), respectively.

Section 2. This local law shall take effect immediately upon its filing with the Secretary of State and shall be applicable to all 1998 assessment rolls prepared on or after January 1, 1998.
